Re: 54 Headland Court - Venetian Blinds Quote, I visited the property today and have quoted for 5 x blinds as per instructions, please see details below.

The Nordan windows, fitted in the recessed windows open inward. Fitting any blinds (other than 25mm Intu /screw fitted venetians) would not allow the windows to be opened. Fitting the 50mm Aluminium Venetians, as specifically requested, above the recess; 'face-fixed' to the wall, is possible. Allowing the windows to be opened when the blinds are drawn up (fully open).

The quote to fit; 50mm, Satin White Aluminium Blinds; either inside or outside the recess is £438.00 + vat.
