Just a few things to note,

I did not realise you were looking for these to be installed outwith hours but I have shown this as an extra over cost on the quote.

If you were to go ahead with the Silent Gliss option the turnaround on these is longer than our own and we do not have control over this, realistically we would need the purchase order to go ahead with these in the next few days to be in with a chance of hitting this timescale of end of February.

Dan noted that a lot of the windows have desks in front of them, we would need these pulled out to ensure our access equipment can be safely used.
