## **GENERAL CONDITIONS OF PURCHASE**

1. No goods will be accepted unless supported by an official Order, signed by an authorised person. No variation of this Order will be permitted unless officially approved.
2. All goods supplied and work carried out must conform to the specification, sample and any other requirements of the Order. In any case, goods or work must be fit for the purpose for which they are supplied or carried out, and the best of their respective kind. The quantity must not be exceeded without written permission, and all consignments must be accompanied by an Advice Note.
3. If specified in the Order, a Representative, duly authorised by us, is to be granted access at all reasonable times to your works (previous notice having been given by us), and allowed to inspect and test the goods to be supplied during their manufacture. Such inspection and tests will not relieve you from any liability and responsibility, or be interpreted in any way to imply acceptance of such goods.
4. If any goods and material fail to pass inspection and tests, or if they are not of a stipulated quality, weight or measurement, or otherwise in accordance with the Order or these conditions, we may either require you within a reasonable time, and at your expense, to replace the rejected goods with goods which comply with the Order, or reject the goods and cancel the Order, but without prejudice to any right of recovering any money paid by us.
5. All goods must be packed in such a manner as to reach us in good condition. Cases and packing materials, which must be clearly marked with our Order Number, are to be free of charge unless otherwise agreed. Where requested, packing material will be returned at your expense, but no liability will be accepted by us in this respect.
6. Any payment made will be without prejudice to our rights, should the goods supplied against this Order prove unsatisfactory or not in accordance with our ordering instructions or these conditions.
7. Delivery to be effected within the date stated on the Order or any amended date agreed by us, and at the place specified on the Order, failing which, we reserve to ourselves the right to cancel the Order or any part thereof forthwith.
8. In cases of strikes, lock-outs, fire, flood, storm, tempest or breakdown of machinery causing stoppage or partial stoppage of our production, deliveries against this Order shall, at our request, be suspended during the continuance of this stoppage.
9. All tools, patterns, drawing and designs supplied by us, or made wholly or partly at our expense will remain our property, and they must not be disclosed by you to any other person or made use of by you, except for the execution of this or subsequent orders.
10. You will keep us fully indemnified against all actions, proceedings, claim, demands, damages, costs, charges and expenses whatsoever brought or made against us or sustained or incurred by us in respect or as result of:
  - (a) Any infringement or alleged infringement of any Letters Patent, Registered Design, Copyright or Trade Mark, by the use or sale of any article goods, or material supplied to us, unless the infringement is due to you having followed our design or instruction.

  - (b) Any Injury, loss or damage to persons or property caused by the negligence of yourselves your subcontractors or agents or by faulty design, workmanship or material, unless injury, loss or damage is caused directly by the acts or omissions of ourselves or of others.
11. The execution of the order or any part thereof is deemed to be an acceptance of our agreement to comply with these general conditions, and no other general conditions. Whether expressed or implied, will apply to this order.
12. These conditions and the order shall in all respects be governed by and construed and operated in conformity with English Law.
