Materials falling from height	4	Ensure fitters are experienced with all tools used. Minimise quantity of materials taken up to working height.	1
Safe delivery of materials and equipment to the place of work	2	Make sure all pathways are clear before bringing equipment to working area. Ensure all packaging is secure. Reduce the amount carried by performing numerous trips to get all required materials to work space safely.	1
Manual handling	2	Fitters are aware of correct manual handling practice. Weight of equipment reduced by limiting the number of products packaged together.	1
Noise and/or Vibration Control	2	Ensure noise kept to a minimum. Inform others within working area when noise or vibration is about to occur.	1
Protection of members of the public	2	Ensure pathways are clear when unloading van. Tools only to be used when on site.	1
Waste removal and disposal	2	All waste / packaging to be removed from site once work is finished. Clear each workspace as soon as each blind is installed so no packaging is left behind.	1
Appropriate Personal Protective Equipment	2	PPE to be worn on site if required. Adhere to site specific regulations.	1

### **WORK ACTIVITIES:**

Installation of new blinds. The blinds to be top into window reveal.

General Tools: Equipment potentially required to complete installation – Pencil, Scissors, Screwdriver, Battery Drill, Screws, Vacuum Cleaner.

Battery Tools: To be inspected by qualified personnel before use.

Platforms: Will be used to access where necessary, provided by Concorde Blinds Direct Limited.

Appropriate Personal Protective Equipment: If required, Hard hat, high visibility vest, steel toe cap boots, gloves – all provided by Concorde Blinds Direct Limited.

### **WORKING HOURS**

The work will be carried out during the day (date and time to be arranged with Site contact). The general working hours will be 8.30am to 5pm.

### **NOISE CONTROL**

Concorde Blinds Direct Limited will carry out the work with the minimum of noise and inconvenience.

### **DELIVERIES**

Are programmed during normal working hours, goods to be taken to site by employees of Concorde Blinds Direct Limited.

Satisfactory arrangements for the safe installation of goods to be agreed with site.

### **WASTE**

Upon completion of the installation, Concorde Blinds Direct Limited will remove their rubbish from site or earlier if appropriate.

### **CHILD SAFETY**

Blinds not required to be child safe as there will be no visitors under the age of 48months in the office space.

### **PROTECTION**

Concorde Blinds Direct Limited will make reasonable efforts to protect finished products where needed.

### **ACCESS**

It is assumed that access to all necessary areas will be allowed and that special restrictions do not apply.

### **FOOD & DRINK**

Food and drink will not be consumed on site, if so, it will be in the site designated area.

### **PARKING**

Parking in designated areas as directed by site contact.
