One-Way Vision Privacy. This can only be achieved using a dark film and is dependent upon the light ratio on either side of the glass. You view from the darkest side to the lightest side. For this reason, the film will only be effective during daylight hours when it is brighter outside. Any light source behind the film causing a back lighting effect may also affect its appearance and effectiveness. The darker and more reflective the film, the more privacy it will provide. If there are other windows/doors behind the windows being filmed, then the day-time privacy effect will be significantly reduced.

With all internal applications of solar film, there is a minor risk of thermal stress breakage of the glass, if the glazing in place is non-toughened glass. However, this risk is minimal. We can only assume that the windows are glazed in accordance with BS6262 Glazing Code of Practice and that there are no existing edge faults within the frame rebate. If the small risk of thermal fracture should occur due to any existing/inherent weaknesses/damage in the glass then we cannot foresee this and hence we are not liable.

Costs assume work in normal office hours with clean and clear access to all windows in one project visit.
