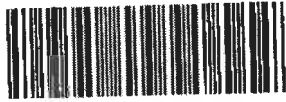

As you told us the motor is tested with test lead and does the same, that is why are preparing to send a replacement motor in exchange, but please note that as I mentioned during our conversation the cable of the motor must be disconnected from the receiver, must be connected directly to the test lead without receiver and must be checked in this way.

We hope that replacing a motor will fix the problem.

Please send a photo of the original motor, after it has been replaced, serial number and date of issue must be visible on the photo.

After receiving it a credit note will be issued for the replacement.

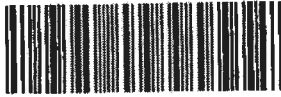
