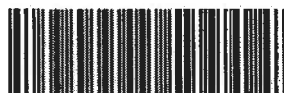

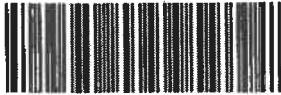

In order to mount all brackets corresponding their fixing base you will need suitable mounting systems. For mounting on concrete C20/25 we recommend heavy duty anchor-systems from fischer (e.g. FAZ II M12/10 GS or FAZ II M12/30 GS). In case of mounting on any other base referred to in our pricelist or on frontal concrete ceiling we recommend the use of injection systems from fischer (e.g. FIS V 360 S). You can order them directly from us.

Thanks for this. Our builder hasn't visited yet but I don't think there will be any problems. I think the very top of the wall will be about 2.9m. I guess the awning cassette will need to be fixed a bit below the top of the wall so that it doesn't show from the other side. So if it is fixed a bit under 2.9m will there be enough headroom at the lowest point when is it extended?

We'd prefer a 4m awning with 3m projection (rather than the 5m which you quoted for previously).
