The Serge 600 and Serge 1% fabrics meet the European standard EN 13501, Class Cs3d0, which stands for low flammability and can therefore be classified as safe. According to the manufacturer Copaco, the fabrics may not meet the German B1 standard according to DIN4102-1 or the French M1 standard. However, they recommend that the goods should be used if German B1 conformity is not absolutely necessary.

Small folds and / or cross marks can appear on the fabric during manufacture, transport or on the construction site.

You can carefully remove these with an industrial hot air dryer.

To do this, set the hot air dryer to max. 250 ° C. Keep a distance of at least 100 - 150 mm from the awning cover and swivel the hot air dryer.

This prevents the fabric from overheating or being damaged.

We use the Steinel HG 2120 E hot air dryer at a medium level and can recommend it.
