The guarantee provides coverage for a full refund, replacement or repair at our discretion.

### 3 year extended warranty

InShade sails made from our exclusive IS100 fabrics are covered by an extended 3 year warranty. Some conditions and exclusions do apply, so please refer to our care instructions and warranty documents for full details.

### 5 year extended warranty

InShade sails made from our exclusive ISX fabrics are covered by an extended 5 year warranty. Some conditions and exclusions do apply, so please refer to our care instructions and warranty documents for full details.

### 5 year guarantee - fittings

All fittings come with a 5 year guarantee that covers performance in use and defects in materials or manufacturing.

### Satisfied or your money back
