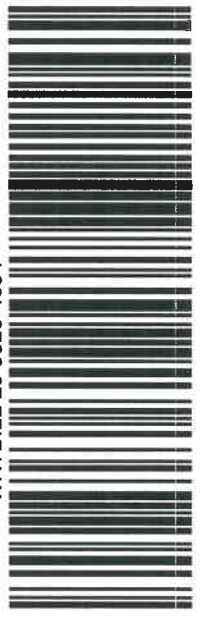

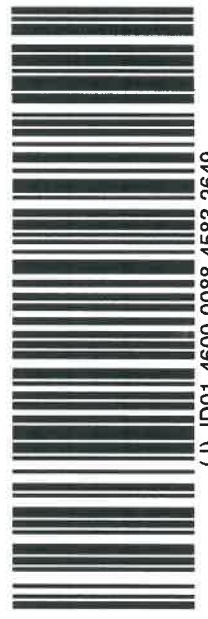

Thank you for this Sharna.

As you can imagine I have a very unhappy customer who doesn't want the light fitting without the diffusing crystals, charge for scaffold tower which will need to be resupplied and additional electricians cost - £100 will not come even close to covering this cost and I don't think such a complete oversight by the manufacturer is acceptable on lights that have cost almost £6,000. Please pass this onto them and request they revisit this offer.

As you said if you can send me the tracking number once you have that.
