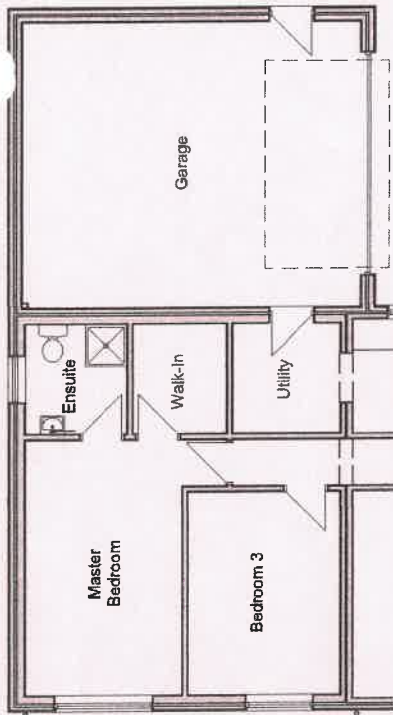

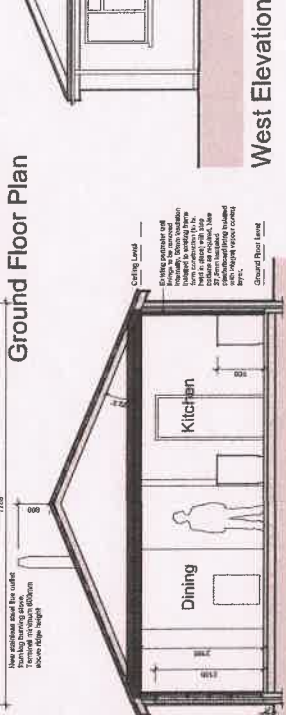
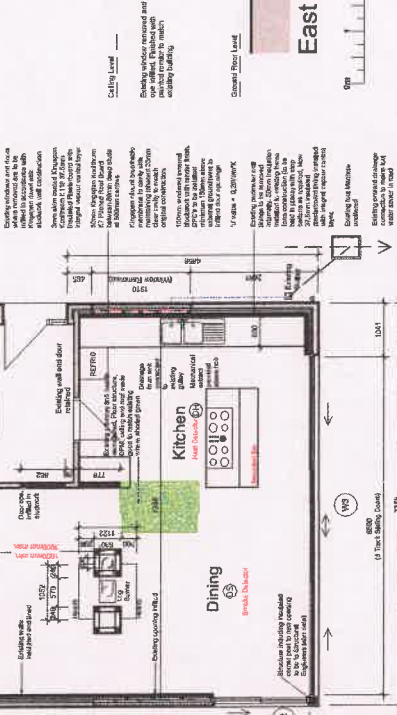


**Wall Detail A**  
Scale 1:20  
(Internal Partition)

Single layer of plasterboard of minimum mass per unit area (10 kg/m<sup>2</sup>) fixed with a minimum distance between fixings of 150 mm. An additional layer of unfaced mineral wool batts density (10 kg/m<sup>3</sup>) which may be, where required, suspended in the cavity. All joints to be well sealed.
