Also if you can confirm a colour RAL 3003 ?



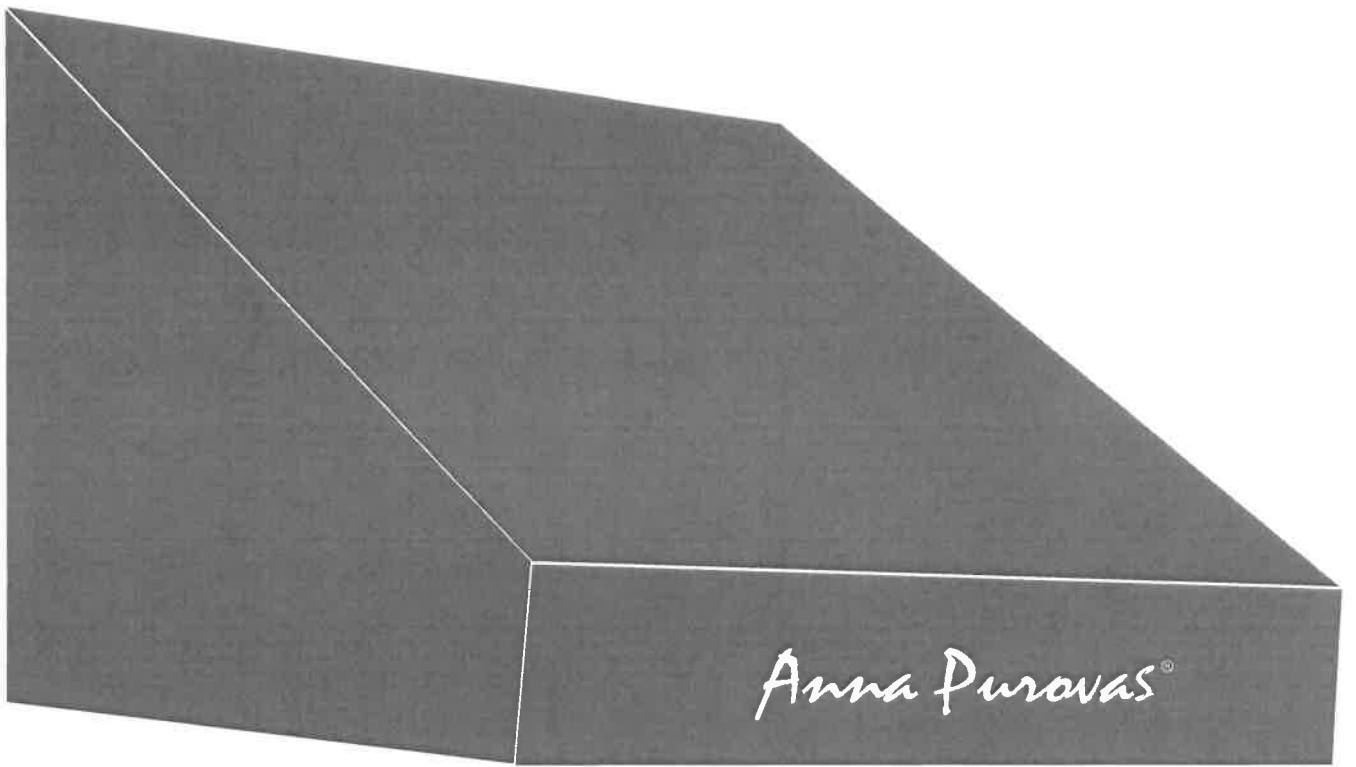
Also we would require your artwork to confirm a costing for signwriting, and if this is required on each awning. Proposed Layout images would be good to see.

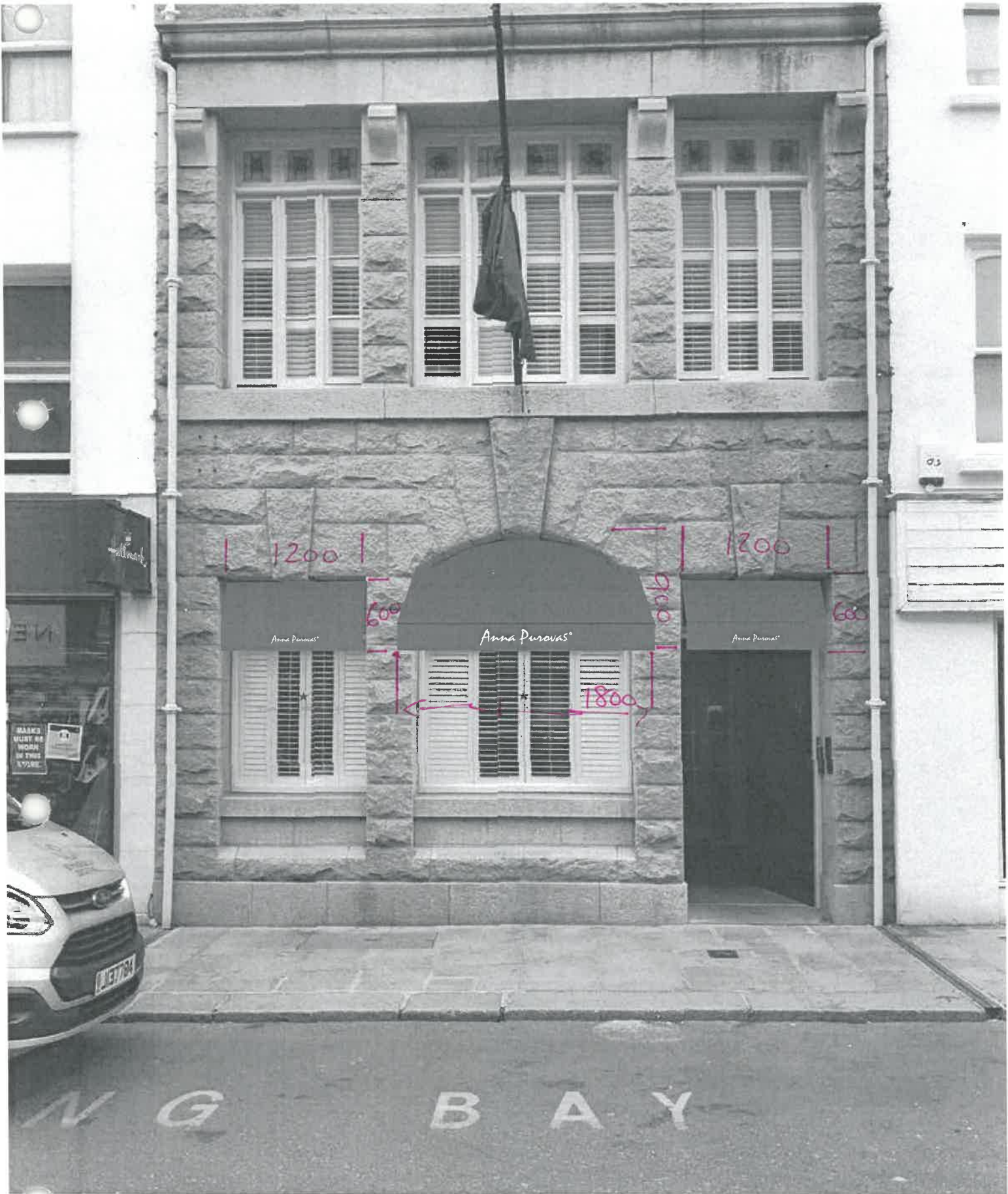
