Thank you for contacting Fabric Gallery and Interiors..

I can see your order now. I can see you ordered fabric direct and also some to be made into curtains via Premierchoice. I'm assuming you must be referring to the 1m piece.

Unfortunately it has been a long time since you ordered. The manufacturers and we both need problems to be reported within 14 days of receipt. In your case for example a replacement will almost certainly no longer be available from the same batch.

You might wish to have a chat with your sewing team who may be able to carefully pull the slub through the fabric using a specialist "snag needle".
