You supplied us with Panama Chrome fabric to create some roller blinds for customer Ref: SO12894 Jenner

We have come across flaws in the fabric. Please review photos attached.

The density of the fabric is thicker than ordered and there are clear white blemishes or marks all over the fabric. This is the case for all rollers we made up with the fabric supplied.

We will require more fabric to re-make these blinds as the customer is aware of the flaws, they highlighted them to us.

Can you please advise this replacement fabric can be sent as FOC?

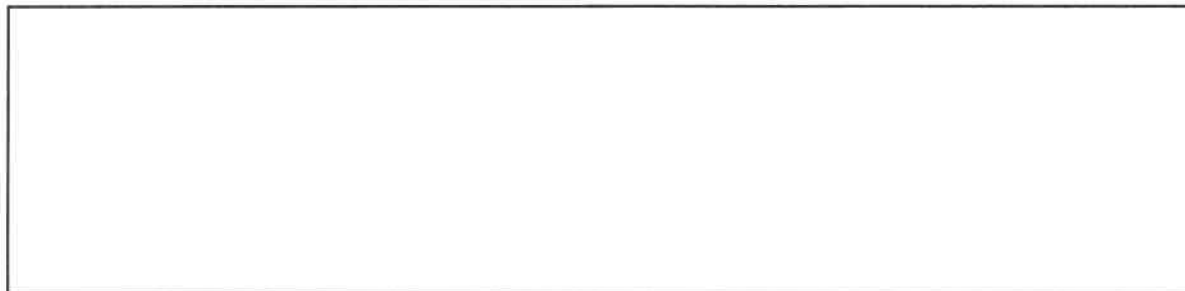
