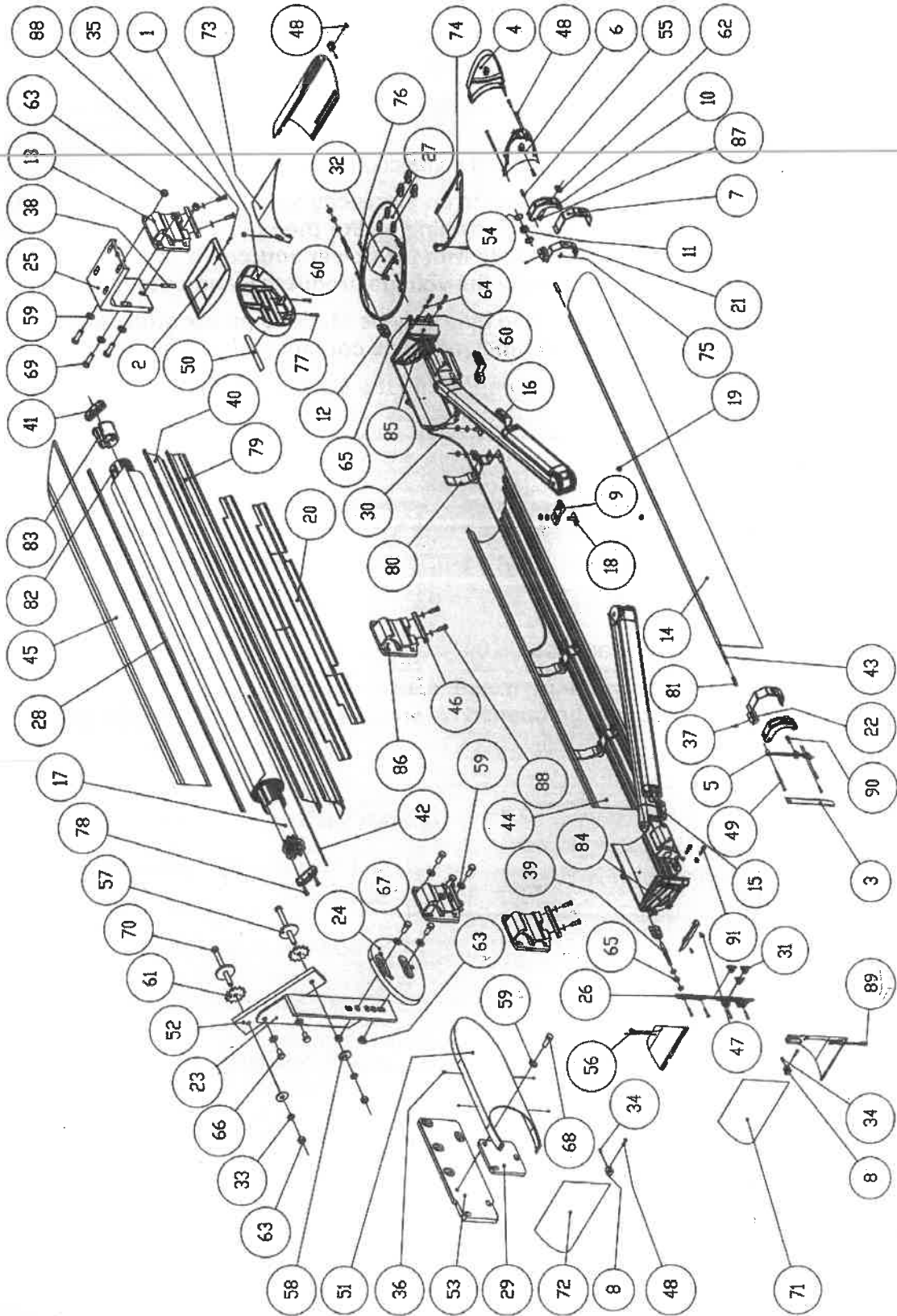


Figure 12: Exploded drawing - Zenara
