You have informed us about noisy Sottezza. Thank you for sending the video.

We have some suggestions to fix the problem, you can try spraying the fabric guide profile with a silicone spray (HHS from Wirth) to eliminate the noise, In addition, the guide pulley and roller should be lubricated, i.e. maintenance should be carried out. This should hep.

Pleas try it and let us know the result, complaint remains open until we get new from you.
