The size, colour etc is perfect, but I went to do an EDE and it would not let me.

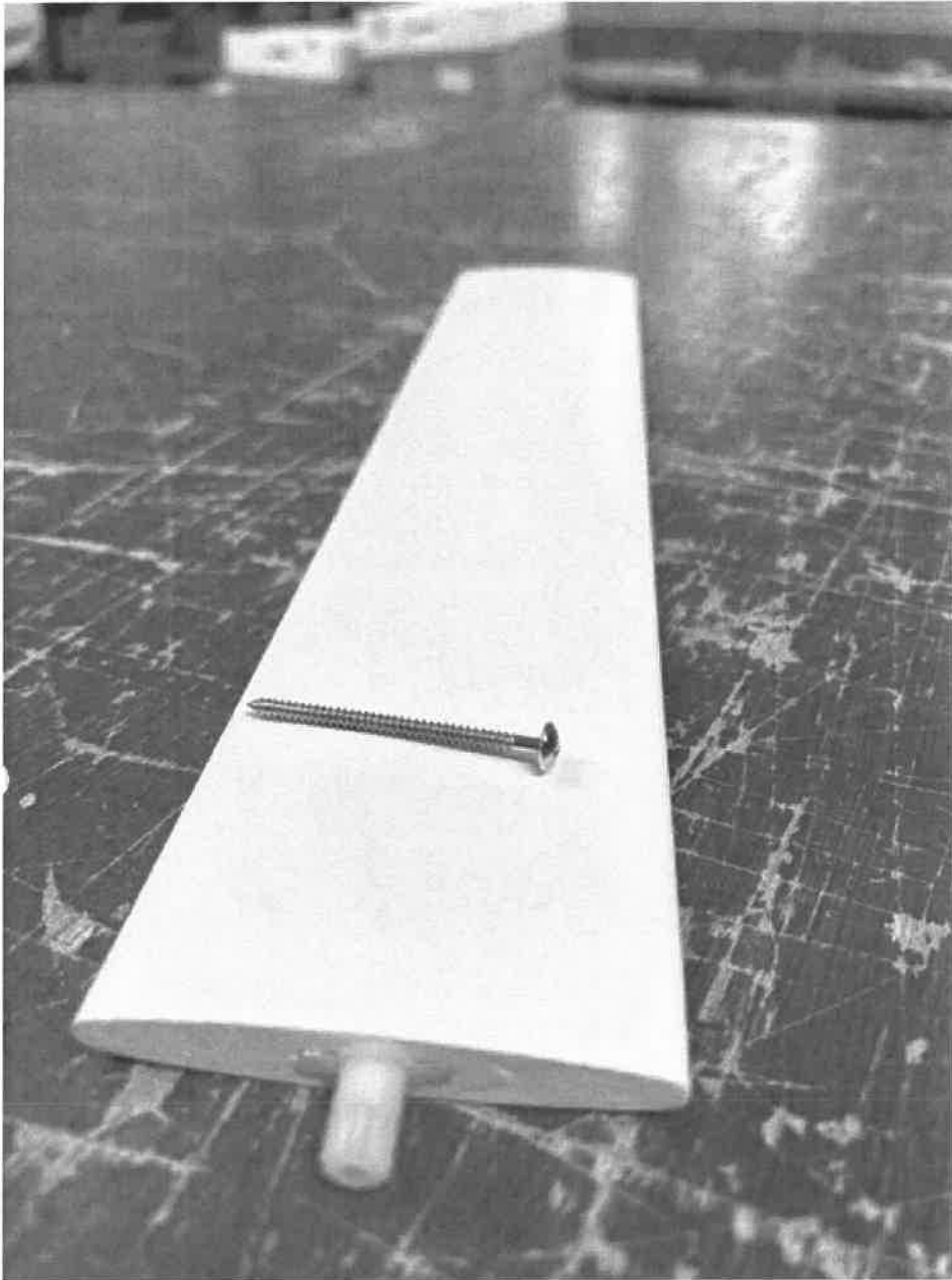
Instead of a screw fix going in, we just need the pins instead.
