We have received an EDR order for remakes of 2 x shutters for Order SO15411 Pippa Campbell. (Dining Area W1, Dining Area W2)
Both shutters are damaged on arrival. The boxes have arrived with 2 huge holes in and the panels are smashed and beyond recovery. There is also chip marks and indents on one of the panels.

We cannot accept these so therefore can I please ask they are made FOC?

The frames are fine, for both windows, it is just the panels inc louvers that are broken for both shutters. I would have filed on the portal but cannot do an EDR for an existing EDR.
