We attended site yesterday and believe it or not, everything worked perfect again. We tested on multiple occasions so are happy there are no major issues but i still have reported your concerns to Weinor.

In our opinion the issue could be that there is an intermittent delay on the receiver. This is very rare and Weinor may advise the receiver needs to be changed as it could be on its way out.

I have filed a complaint and report on their system this morning. They are usually quick at responding. As soon as i have feedback i will let you know.
