Hi Sally,

Would you please be able to prepare a quote for the following (if fabric is enough):

- 2x 35cm x 30cm cushions (option with and without piping) *GP & J Baker Lilington Blush (main)*
For this we have two pieces of fabric that are approximately 120mm wide by 35mm long). We know it is not possible to pattern match front and back. For the option with piping, we would have to order a plain fabric so we would need fabric quantity required. *ChNasso Kingham reloaded CH2911/065 piping*
- 2x 50cm x 50cm cushions (option with and without piping)
- 1x 45cm x 30cm cushion (option with and without piping)
For this we have a large 1.40m wide (full width of the fabric) by 1.10m long piece and 1x 1.40m wide by 68cm long piece. If it can't be pattern matched is not a problem
