In case of mounting on any other base referred to in our pricelist or on frontal concrete ceiling we recommend the use of injection systems from Fischer (e.g. FIS V 360 S). You can order them directly from us.

If you use a different mounting system or your own brackets, you will need a table of pull-out resistance of screw anchors in order to determine the working load.
