1. Introduction

2. Orders & Deposits

2.1 All goods are made to order and customised to the customers specifications. Once an order is placed, changes may not be possible.

2.2 A non-refundable deposit of 50% of the total order value must be paid when accepting the quote. The order will not be processed until this payment is received.

2.3 The remaining balance must be paid in full at least two (2) days prior to installation or delivery. Failure to make full payment may result in delays or cancellation. Unless prior written agreement from the directors of Creative Curtains & Blinds Ltd has been agreed.

3. Cancellations & Refunds

3.1 As all products are bespoke and made to order, orders cannot be cancelled or refunded once manufacturing has commenced.

3.2 The deposit is non-refundable except in cases where we are unable to fulfil the order due to circumstances beyond our control.

4. Delivery & Installation

4.1 We will provide an estimated lead time at the point of order, but this is subject to change due to material availability or unforeseen delays.

4.2 The Customer must ensure that the installation area is accessible and free from obstructions at the agreed time. If installation cannot proceed due to the customers circumstances, additional charges may apply.

4.3 Any issues with installation or delivery must be reported within 48 hours.

5. Measurements & Specifications

5.1 It is the customers responsibility to check your order form once received to ensure all details are accurate. If the customer has provided measurements themselves, it is the customers responsibility to check these are correct. No refund or replacements will be made if the measurements are supplied by the customer and are wrong. liable for errors due to incorrect measurements unless we have conducted a site survey.

6. Warranty & Liability

6.1 We offer a 12 month warranty on manufacturing defects. This does not cover wear and tear, accidental damage, or incorrect use. This will vary depending on the product.

6.2 We are not liable for any damage caused by improper installation (if not installed by us) or failure to follow care instructions.

6.3 Our liability is limited to the value of the goods supplied. We are not responsible for consequential losses.
