<i>50/50: 50% deposit with order, remaining 50% payment a least 2 weeks prior to installation. If survey is completed, the products are ordered and installation is delayed by the client, the final payment is required to be paid.</i>

<i>Additional Charges</i>	
<i>Please note that that we cannot survey until all structures that affect blind measurements are in place (e.g. plasterboard & plaster, joists, window sills, skirting boards, tiling, architrave etc.).</i>	
<i>When the blinds are installed, all plasterboard work, floor work and decorating must be complete unless otherwise agreed in writing. In order to prevent damage to the blinds, the environment must be entirely dust free and watertight. The customer is responsible for clearing the room in which survey or installation is to take place and to allow reasonable access for work.</i>	
<i>If any of the above is not adhered to additional charges may apply.</i>	
<i>If any changes are made by the client after the survey, or any agreed building requirements are not put in place by the client prior to installation resulting in a problem with the products, any extra work required from this will be chargeable to the client.</i>	
<i>Access</i>	
<i>Access equipment for installations over 3600mm off floor level or specialist equipment is not included in the quote and will need to be provided by the main contractor.</i>	
<i>Power Supply and Wiring</i>	
<i>240V fused spur to be provided by the client/main contractor prior to installation. Price includes for concealed low voltage wiring during construction of the building provided the products are ordered in sufficient time.</i>	
<i>Controls and AV Integration</i>	
<i>Unless stated, our proposal does not allow for any products to enable blinds to be controlled by a 3rd party AV control system. Pricing for this will be provided once the specified requirements are confirmed by the AV company responsible for the integration. Pricing allows for the commissioning of blinds.</i>	
<i>Blindspace Installations</i>	
<i>It is recommended that the blinds and Blindspace products are ordered together to ensure that the end result can be project managed and guaranteed by Grants Blinds and not subject to change of specification that may affect the dimensions required.</i>	
<i>Products are on a supply only basis, following an initial guidance and/or survey by Grants Blinds. Unless otherwise agreed the contractor will do the installation and not Grants Blinds. Once installed the areas around the Blindspace boxes will need to be finished off by the contractor after the installation and commissioning of blinds.</i>

Delivery for Blindspace boxes is 4-6 weeks from signed off schedule by the clients' project manager. Design for inclusion of Blindspace remains the responsibility of the client or the clients' representatives. Grants do offer a Blindspace installation service charged at a day rate of £850 ex vat or can provide a quotation on a job-by-job basis.

Delivery for blinds is 8-10 weeks from final survey and specification being completed. Installation time 2-3 weeks.
