Pricing

Zero rated VAT, includes installation and excludes any import duties the client will be liable for. The quotation is valid for 1 month and needs to be repriced after 6 months. Pricing assumes installation by end of Q3 2024 - early order is recommended to enable Grants to assist with the design integration with Tanglewood Conservatories and project management to ensure smooth running on site.

Installation period to be agreed and pricing may be subject to price increases if project is delayed or takes more than 12 months to complete from time of order. Increases will be tied in with supplier costs and inflation rates at the time.

Prices allow for up to a 6% increase in supplier pricing during the expected project completion period but should raw material or travel cost change significantly due to situations outside our control then further increases may have to be passed to the client.

Warranty - Overseas Installation:

All products are guaranteed for 2 years, worn and defective parts replaced free of charge but travel related costs and time on site are chargeable.

Payments:

50/50: 50% deposit with order and balance at least 2 weeks prior to despatch of goods to site unless otherwise agreed. If survey is completed, the products are ordered and installation is delayed by the client, the balance payment is required to be paid.
