The customer is responsible for clearing the room in which survey or installation is to take place and to allow reasonable access for work.</i>

<i>If any changes are made by the client after the survey, or any agreed building requirements are not put in place by the client prior to installation resulting in a problem with the products, any extra work required from this will be chargeable to the client.</i>	
<b>Access</b> <i>Access equipment for installations over 3600mm off floor level or specialist equipment is not included in the quote and will need to be provided by the main contractor.</i>
