## Product Warranty

We would like to thank you for purchasing this product and feel sure you will be happy with your choice for many years to come, as it was designed and manufactured to your individual needs and specifications to give you maximum satisfaction.

On the **DIY Roller Garage Door**, Rollerdoor Ltd offers that for a period of (2) Two years. Parts will be covered from your product's delivery, should it prove to be defective due to workmanship.

On the Somfy Control Systems and Motors, Rollerdoor Ltd offers that for a period of (5) Five years. These parts will be covered from your product's delivery, should it prove to be defective due to workmanship.

The warranty period for replacement parts is 6 months or to the end of the current warranty period, whichever is longer. Non consumable replacement parts (e.g. motor) purchased from our parts shop are supplied with 6 months warranty from date of dispatch consumable.

## Warranty Conditions

Subject to the under-mentioned specific limitations and exceptions, Rollerdoor Ltd warrants all new doors, motors and electronic components of its manufacture to be free from defect in workmanship under normal use and service and further warrants all installation carried out by Rollerdoor Ltd to be free from defects and workmanship, its obligations hereunder being limited to making good any such defect PROVIDED THAT notice of any claimed defect in material workmanship in or resulting from installation of any door shall have been given to the manufacturer within a reasonable period from date of installation/delivery.

Rollerdoor Ltd will not be liable in respect of any defect arising from wear and tear, wilful damage, negligence, abnormal working conditions or failure to follow the instructions ( whether verbal or in writing ) including but without limitation: (a) electrical work external to the product; (b) transportation or relocation of the product not by the supplier; (c) any error or omission relating to the product; (d) any modification, adjustment or repair to the product made by a third party without the written consent of the supplier; (e) the subjection of the product by the customer to unusual physical or electrical stress; (f) the door striking an immovable object during travel; (g) failure of electrical power, or any other cause which is not due to the neglect or the default of the supplier, its employees, agents or subcontractors.

The liability of Rollerdoor Ltd shall be no more than the price and/or services, except in the case of death or personal injury caused by the supplier's negligence.

Rollerdoor Ltd cannot be held responsible for any loss or damage that was unforeseeable to both parties at the time the contract was formed.

Rollerdoor Ltd is not responsible for indirect losses which happen as a side effect of the main loss or damage and which are unforeseeable by either party (such as loss of profits or loss of opportunity).

## Items Excluded From Warranty

## Conditions Of Sale And Installation

Any delivery and/or installation dates given are approximate only and Rollerdoor Ltd accepts no liability for delay from any cause whatsoever, including but without limitation to Act of God, war, government or semi-government enactment, regulation or restriction, lock-out, strike, industrial dispute, fire, tempest, flood, failure or inability to obtain licenses, transport of materials or any other cause beyond Rollerdoor Ltd's control. If delivery or installation is delayed, Rollerdoor Ltd may extend the time of delivery or installation or, if Rollerdoor Ltd is unable to deliver or install, the contract shall be voidable at Rollerdoor Ltd's option with no right to either party for damage, loss, cost or expense.
